To qualify to sit for the licensure exam, students must submit the Application for Approval to Take Examinations – Plumbing to DOPL which contains transcript verification of four years of school and employer's verification documenting 8,000 hours of supervised work experience as a licensed apprentice Plumber or employers' verification of 16,000 hours of supervised work experience as a licensed apprentice Plumber.
